Employment Update: Checklists for Reopening in Napa and Marin Counties *Posted May 26, 2020*

For employers with businesses in Napa and Marin Counties, the following are the reopening guidelines for businesses that are now allowed to reopen (with restrictions) during Phase 2 in each County as well as essential businesses that continue to operate in the counties.

Napa County

ALL businesses in Napa County must follow these requirements:

- While not required, businesses are also encouraged to follow the BMPs from the County for their industry to the extent the County has made them available. Currently the Napa Valley Chambers of Commerce has guidance available for the following industries:

As of May 19, 2020, the following businesses are allowed to reopen in Napa County after complying with the requirements for their industry:

- Retail stores, including shopping malls and swap meets
- Dine-in restaurants
- Schools effective June 1, 2020

Lastly, Napa County allows for both public and semi-private swimming pools to open subject to the rules of the facility, proper maintenance including disinfection, and adherence to social distancing protocols. On May 18, 2020 Napa County released the following information regarding the safe operation of public pools and spas:

Marin County

Under the County's most recent Shelter in Place Order dated May 15, 2020, all businesses that are allowed to operate in Marin County are required to do the following:

- Implement a <u>site-specific protection plan ("SPP")</u> that incorporates the industry-specific guidelines for that business. If a business is already operating, they have a grace period until <u>June 1, 2020</u> to implement and comply with the SPP.
